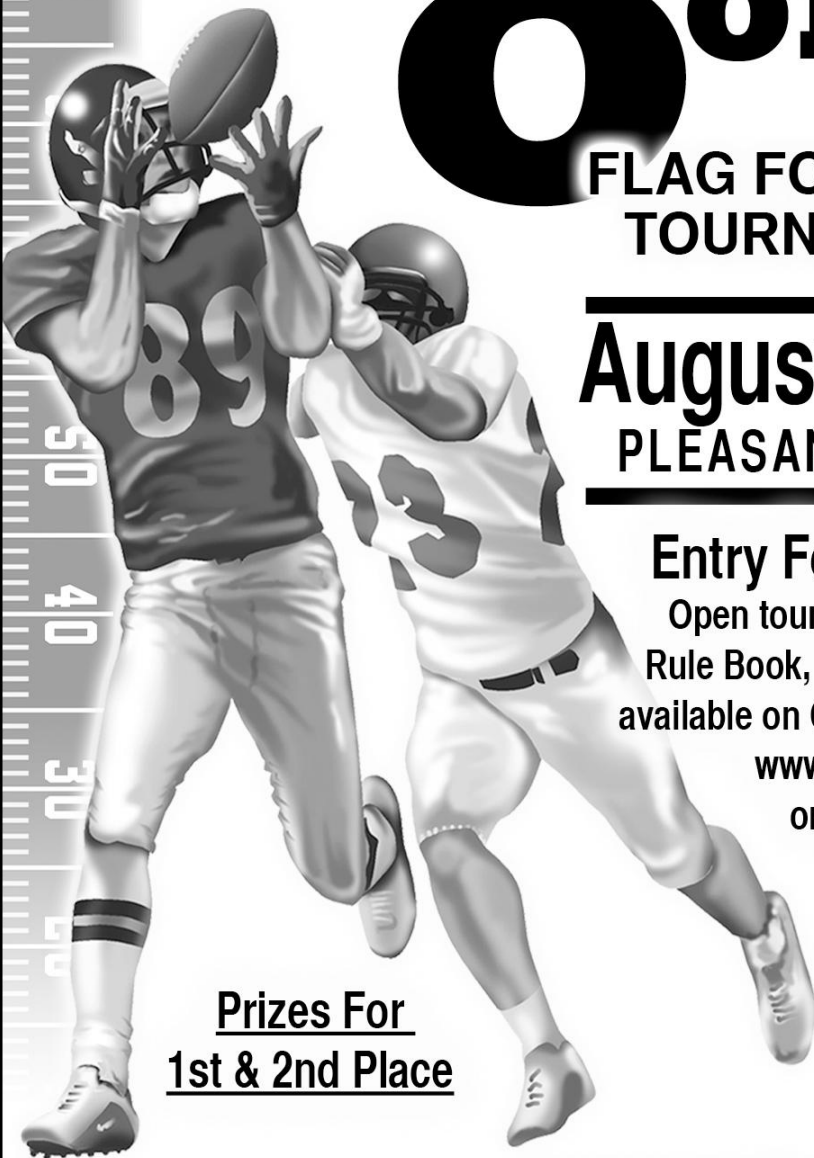

ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I HEREBY ASSUME ALL OF THE RISK OF PARTICIPATING AND/OR VOLUNTEERING IN THE ACTIVITY OR EVENT, including by way of example and not limitation, any risk that may arise from negligence or carelessness on the part of the Pleasanton Cowboy Homecoming, Pleasanton Chamber of Commerce, The City of Pleasanton, and/or its board members, directors, officers, employees, volunteers, representatives, and agents, Activity or Event holders, Activity or Event sponsors, and Activity or Event volunteers (collectively, the "Released Parties") from dangerous or defective equipment or property owned, maintained, or controlled by the Released Parties, or because of said parties potential liability without fault. I certify that I am physically fit, have sufficiently prepared or trained for the participation in the Activity or Event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in the Activity or Event. I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the Activity or Event in which I may participate, and that it will govern my actions and responsibilities at said Activity or Event. In consideration of my application and permitting me to participate in the Activity of Event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors and assigns as follows:

(A) I WAIVE, RELEASE AND DISCHARGE THE RELEASED PARTIES FROM ANY AND ALL LIABILITY, INCLUDING BUT NOT LIMITED TO, LIABILITY ARISING FROM THE NEGLIGENCE OR FAULT OF THE RELEASED PARTIES, FOR MY DEATH, DISABILITY, PERSONAL INJURY, PROPERTY DAMAGE, PROPERTY THEFT, OR ACTIONS OF ANY KIND WHICH MAY HEREAFTER OCCUR TO ME DURING OR TRAVELING TO AND FROM THE ACTIVITY OR EVENT.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE THE RELEASED PARTIES FOR ANY AND ALL LIABILITIES OR CLAIMS MADE AS A RESULT OF MY PARTICIPATION IN THE ACTIVITY OR EVENT, WHETHER CAUSED BY THE NEGLIGENCE OF OR FAULT OF THE RELEASED PARTIES. I acknowledge that the Released Parties are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting the Event or Activity on their behalf. I acknowledge that the Activity or Event may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers. I hereby consent to receive medical treatment which may be deemed available in the event of injury, accident, and/or illness during the Activity or Event.

(C) I understand that during the Activity, Event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for editorial, trade or advertising purposes by the event holders, producers, sponsors, organizers, and their assigns. This Accident Waiver and Release of Liability Form shall be governed by Texas law and constructed broadly to provide a release and waiver to the maximum extent.
