# PLEASANTON COWBOY HOMECOMING

March 9<sup>th</sup> & 10<sup>th</sup>

Dear Food Vendors:

The 51<sup>st</sup> Annual Pleasanton Cowboy Homecoming/Turn n Burn Cook off will be held on March 9<sup>th</sup> & 10<sup>th</sup>, 2018, at the Pleasanton River Park at 900 River Park Rd. This year, food will be sold on a cash basis.

**INSURANCE REQUIREMENT FOR 2017-** Our insurance company requires all vendors to provide their own General Liability Coverage including Products and Completed Operations per Occurrence \$1,000,000. Certificate of Insurance must name the Pleasanton Chamber of Commerce and Cowboy Homecoming as additional insured's. If you do not have a policy, you must be added to the Chamber's policy at a cost of \$65.00 per booth. If you are approved to sell items, we will need your payment for the insurance requirement no later than March 1, 2018 (Subject to change based on rates from insurance company).

**SALES TAX-** All vendors (unless tax exempt) are responsible for submitting ALL applicable taxes to the proper agencies. Please contact your nearest Texas State Comptroller's Office or call (800)262-5555.

**FOOD ESTABLISHMENT PERMIT** – The City of Pleasanton requires all food vendors to have a Food Establishment Permit. You must complete the form and take it to City Hall in Pleasanton and pay the required Permit Fee. **Deadline for turning in Permit Form and fee is March 1.** When you receive your permit, you will need to submit a copy to the Pleasanton Chamber of Commerce.

**Food Handler License** – The City of Pleasanton requires all food vendors to have a Food Handler License and have with them at all times during the event.

Vendor will receive 1 parking pass only. NO EXCEPTIONS, so do not inquire! Additional wristbands may be purchased.

Vendors are not granted exclusive rights to sell any particular item. The Pleasanton Chamber of Commerce will retain the right to determine which of a vendor's products are approved for sale. The Pleasanton Chamber of Commerce will limit vendor rights to sell multiple food offerings in an attempt to achieve and maintain variety and profitability for all vendors. In the event of a dispute, the decision of the Pleasanton Chamber of Commerce will be accepted as final. The Pleasanton Chamber of Commerce has the right to **Refuse** anyone and a full refund will be issued. **Please respond by February 15, 2018, by returning the attached form.**

Please complete the attached form in its entirety. After approval, a contract will be mailed to you for your execution.
